## About the DCA Intern Experience

-  8 week internship, 28 hours per week in a flexible work environment. Work from DCA headquarters, remote, public meetings and events (both in-person and virtual), as well as on-site field visits as available
-  Develop professional work skills: analysis and synthesis of information; how to effectively present to small and large groups; work as a team to create new content; gain project and time management skills and learn how to develop clear and concise communication tools
-  Learn from world-class experts working with the State on environmental permitting, engineering and design of upgrades to water conveyance systems, and communications strategies
-  Learn how sustainability concepts can be incorporated into large public projects and ways California can be more resilient to increasingly extreme weather events, earthquakes and other natural disasters
-  Tasks performed may include data analysis, review of materials, drafting of summary memos, attending project meetings, entering data into computer datasheets and databases, assisting with technical report writing and research

- ### MINIMUM QUALIFICATIONS
- Current enrollment in an accredited four-year college or university maintaining a cumulative grade point average of 2.75 or higher
  - **Knowledge of the California Delta (Confluence of the Sacramento and San Joaquin Rivers) - highly desirable**

## ABOUT THE DELTA CONVEYANCE AUTHORITY

The Delta Conveyance Design and Construction Authority (DCA) is a Joint Powers Authority formed in 2018 by public water agencies to participate in the update of infrastructure in the Delta to protect the water supply of 27 million Californians.

The Department of Water Resources (DWR) owns and operates the State Water Project system, and oversees the work of the DCA. The DCA has assembled world-class experts, who have been tasked with conducting conceptual engineering work to help define a project consistent with Governor Newsom's single tunnel solution. This project is a key element of Governor Newsom's portfolio of Statewide water actions to build a resilient water supply for California.
